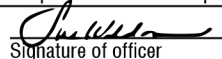
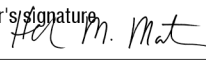

UNITE FOR HER FUNDS AND DELIVERS UP TO \$2,000 WORTH OF INTEGRATIVE THERAPIES THAT EACH PATIENT CHOOSES OVER THE COURSE OF ONE YEAR TO HELP MITIGATE UNWANTED SIDE EFFECTS AND SYMPTOMS DURING TREATMENT AND BEYOND. THIS YEAR WE SERVED A TOTAL OF 4,378 PATIENTS, WITH 2,452 BEING NEWLY DIAGNOSED WITH BREAST OR OVARIAN CANCER AND 1,926 PATIENTS LIVING WITH METASTATIC DISEASE OR RECURRENT OVARIAN CANCER.
