A Year in Review

Unite for HER (UFH) experienced significant growth in 2013, and expects that trend to continue given the increased demand for their programs in the Philadelphia area. UFH is leading the change they want to see in the medical community where complementary therapies are embraced and endorsed as a vital part of each patient's prescribed treatment plan. The mission and vision of the organization compels their efforts to provide financial and emotional support directly to the women and families they serve. This goal is achieved through a variety of outreach opportunities such as grants, wellness day events, speaking engagements, social media and educational materials.

UFH is honored to be working among the best hospitals and medical providers to bring complementary healing to breast cancer patients. When the wellness day program began in 2010 at Paoli Hospital, they welcomed 30 women to experience the event. They are now impacting over 500 women in 10 area hospitals by equipping them with the tools they need to restore themselves in body, mind, and spirit. This is accomplished through a series of small group presentations and interactive discussions that educate patients regarding the healing power of acupuncture, massage, yoga, Reiki, professional counseling, and nutrition. Each attendee also receives vouchers for the therapies they would like to pursue and educational resources that promote a healthy lifestyle, all funded by UFH.

In 2013, UFH expanded their focus on the positive impact of good nutrition. Given the incredible benefits of even small dietary changes, this message was shared at every opportunity and to all audiences. Their commitment to nutrition education also led to the decision to bring real food to wellness day participants through a CSA (community supported agriculture) membership with Lancaster Farm Fresh Cooperative. Each patient received a weekly supply of fresh, organic, locally grown vegetables. The produce, combined with a nutritional consultation led by professional advisor, Katie Cavuto, and other food buying and preparation service options, gave patients and their families the tools they needed to enjoy meals that strengthened and restored. Over 260 women accepted this incredible benefit in the first full year of implementation, and many have reported significant changes to how they view and choose foods now that they have a greater understanding of their healing power.

Grants

UFH saw a rise in grant applications in 2013. The Path to Healing Grant is currently offered directly from UFH, but is also extended to patients in partner hospitals such as Magee-Womens Hospital and the Dana-Farber Cancer Institute. The Path to Healing Grant offers similar financial support for integrative therapies to those received by wellness day participants. Each recipient is encouraged to use the vouchers to seek treatments from a list of UFH approved providers that specialize in caring for breast cancer patients. In 2013, the number of Path to Healing Grants tripled, and over \$36,000 was awarded to women eager to explore the many benefits of complementary therapies. Through our Pink Invitational~Gymnasts Unite event, grants were also awarded on behalf of UFH to Magee-Womens Hospital, St. Francis Hospital, and Hartford Hospital.

The original grant program created for gymnasts, coaches, and judges will see some exciting changes next year. UFH awarded \$22,000 to families in the gymnastics community in 2013, and is in the planning stages of making significant improvements to the grant process to move towards rolling applications throughout the year so families can receive the support they need in a timely manner. The Pink Invitational continues to be their largest fundraising and outreach event, providing incredible opportunities to share educational messages with thousands of young athletes and event attendees. UFH is thrilled to give back to such a generous, loyal, and compassionate group.

Education and Outreach

Education is the cornerstone of UFH outreach efforts. Empowering women through wellness education is essential to finding strength, healing, and control when battling and overcoming a disease. This year, UFH founder, Sue Weldon, had the pleasure of speaking to over 5,000 women, survivors, students, and young athletes about the importance of being your own health advocate and making educated choices for overall health and wellness. UFH was invited to present at various local business, community, school, and healthcare events to inquisitive audiences who were hungry for knowledge and information.

One such outreach that continues to thrive and spread to surrounding schools is the Students Unite for HER program. This fundraising and breast cancer awareness initiative was founded in several local high schools, but has grown to include 18 schools, private athletic teams, and colleges. Each group that hosts a 'pink' event to benefit UFH receives educational resources, a guest speaker presentation, and the opportunity to earn a breast cancer grant for one of their fellow students, team members, teachers or staff. This year, six grants were awarded for a total of \$10,000. UFH anticipates this movement will continue to explode in the coming year and is thrilled to empower younger generations to effect change and give back to their communities.

Vision for the Future

The staff and board of UFH are determined to see the organization succeed by limiting the growth rate and ensuring the high standard of programming is maintained. While the desire is for every hospital in the Philadelphia area to offer the wellness day program to their patients, that must be tempered with the balance of available resources and time. UFH is intentional about building relationships and exploring opportunities that will maximize impact and bring needed resources to women with breast cancer without sacrificing quality. UFH hopes to add several new hospital partnerships in the coming year, and extend the wellness day and grant programs in areas where the financial need is the greatest. UFH is steadfast in their ambition to keep a personal touch and hands-on approach to delivering their unique message. This philosophy of controlled growth also applies to other areas of outreach such as speaking engagements, Students Unite for HER, and fundraising events.

UFH welcomes volunteers with all types of skills and interests, and appreciates the sacrifice of time and talent given by so many in the past year. They are grateful for those who completed simple, time-consuming tasks such as organizing event materials to those hosting fundraising events on behalf of UFH. Every minute and every dollar given to UFH counts towards changing the life of someone affected by breast cancer. The Team

The expansion of UFH programs would not be possible without their dedicated team of volunteers, staff, board members, and expert advisors. 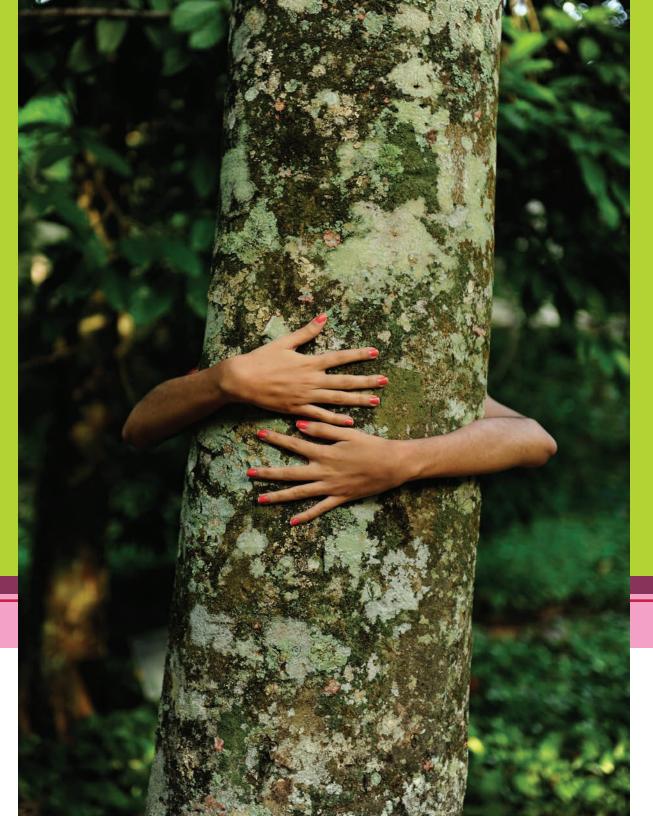
